OPEN FORUM: There were no members of the public present. The council had been asked to consider keeping the telephone box in North Huish as it is a significant structure within the village. It was agreed to investigate this further. The Council was informed of an attempted break in at an isolated building within the parish. It was agreed to bring this to the attention of parishioners who are encouraged to take all precautions possible to protect their property. Attention was also drawn to overhanging branches on the road from Avonwick towards North Huish. The landowners would be asked to check these. The parish now has an allocated police officer.
